

Regulations for Research and Monograph Incentives for Full-Time Faculty of the Department of Law, National Chung Hsing University

Passed in the 52nd Department Affairs Meeting on November 11, 2014.

Amended and passed in the 66th Department Affairs Meeting on December 17, 2015 (Articles 4, sections 1, 2, and 3).

Amended and passed in the 76th Department Affairs Meeting on November 15, 2016 (Articles 2, 4, 5, and 6).

Amended in full, including the title, and passed in the 88th Department Affairs Meeting on January 9, 2018.

Amended and passed in the 93rd Department Affairs Meeting on May 15, 2018 (Article 2).

Amended and passed in the 136th Department Affairs Meeting on November 30, 2021 (Article 4).

Amended and passed in the 149th Department Affairs Meeting on February 14, 2023 (title, Articles 3, 4, 5, and 6).

Article 1

The Department of Law at National Chung Hsing University (hereinafter referred to as "the Department") has formulated these regulations to enhance the academic standards of legal education.

Article 2

The application for research rewards for full-time faculty members of the Department is divided into two categories:

1. New legal publications included in TSSCI (Taiwan Social Science Citation Index) tier 1, tier 2, or SSCI (Social Science Citation Index) journals (Category: LAW).
2. Legal monographs, textbooks, or anthologies included in the "NCHU Law Series."

Article 3

Works that have already been rewarded by other organizations are still eligible for application under these regulations.

Pursuant to these regulations, applicants seeking rewards for eligible works approved by the Editorial Committee of NCHU Law are entitled to the following business expense incentives:

1. **Legal Articles Published in TSSCI Journals:**
 - (1) For Tier 1 journals: NT\$10,000.
 - (2) For Tier 2 journals: NT\$6,000.
2. **Legal Articles Published in SSCI Journals (Category: LAW):**
NT\$6,000.
3. **NCHU Law Book Series:**
 - (1) The total reward budget for the NCHU Law Book Series per academic year is NT\$100,000.
 - (2) For independently authored monographs: NT\$30,000; for textbooks: NT\$20,000.
 - (3) For edited collections or co-authored books: NT\$20,000–30,000.

The business expenses referred to in the preceding article shall be reimbursed upon the applicant's submission of supporting receipts to the department office. Applications for rewards must be submitted within one year of the publication date or the date of acceptance for publication. Late submissions will not be accepted.

Article 5

The review of the rewards in the preceding article will be decided by the Editorial Committee of NCHU Law. The review may, if necessary, be conducted via electronic mail communication.

Article 6

For works accepted for rewards and included in the "NCHU Law Series," the applicant must publish the work within six months after receiving the reward, in accordance with the format specified for the cover and spine of the "NCHU Law Series."

Article 7

These regulations shall be implemented after being passed by the Department Affairs Meeting. The same procedure applies for any amendments.

In case of any dispute, the explanation should be based on the Chinese version.
